Enhancements

Note: Existing reports that have not yet been enhanced remain in the Reporting tab. However, the tab is now located under the Help option.

- The Date Case Complete program has been updated to include the 2023 primary surgery fields
- The following menu items have also been re-written in the new platform; however, the functionality is unchanged: User Security, Import Config Screen, Global DIR, DB Validation
- The following states now have the version 23 export: **AR, AZ, GA, IA, ID, IL, KS, LA, MA, MD, MN, MO, MT, NC, NJ, NM, NY, OK, OR, PA, SC, TN, TX, WI, WV, WY**

Corrections

- A correction has been made to correct the font on the Hemopoietic/Immuno/Other Text label as well as the Chemotherapy Text labels on the individual modality screens
- Some histology codes that were missing the first letter to their descriptions have been corrected
- A correction has been made to return the functionality to open the drop-down options with the down arrow key
- Select a Pop has been corrected to allow items to be searched by description and the Edit Select feature can also now be used to modify the selection criteria
