Enhancements

- A new NAACCR v23 field, Patient Contact, has been added to the Patient Maintenance screen. This field is to be coded in the following circumstances:
 - If a patient or family member contacts the cancer registry to inform the registry that the patient is willing to be contacted for research purposes or that they wish NOT to be contacted
 - If the state contacts the cancer registry to inform the registry that the patient is willing to be contacted for research purposes or that they wish NOT to be contacted
 - o Note: This field may be left blank and will default to 0. Help notes are available.
- Security enhancements have been put in place to increase performance
- Menu options of Export Viewer, Old Canned Reports, Old Data Exports, and Old Reporting
 Utilities have been removed. Please use the Enhanced reporting menu for canned reports,
 data exports and reporting utilities. The Export Viewer is no longer applicable.
- The TNM edition on the staging screen will default to the 9th edition for the new 9th edition
 AJCC chapters when left blank

Corrections

- A correction was made on the state data export screen to prevent errors while using the zip file option or the download button option
- The Copy Abstract function was updated to no longer copy over the breast surgery here fields
- The table name field was added back to the Global Dir screen, located under the Utilities tab in the System Administration tab
- A correction was made to save the screening date on the CPM screen appropriately
- The Custom Forms and Follow-up Letters screens have been corrected to be able to add spaces
- The NAACCR Export has been corrected to not export values in the SORS summary field or Surg-Prim Site 03-2022 field for older diagnosis years prior to 1998

- Florida The historical grid has been corrected to properly calculate schema ID without error
